**AD.1. Opening the meeting of the Interdisciplinary Team to Collaborate in the Implementation of the "Open Krakow" Program.**

Elżbieta Kois - Żurek - the Chairwoman of the Team welcomed everyone present at the 6th meeting of the Interdisciplinary Team in 2019, then put the agenda to the vote. The agenda of the meeting - **Appendix 1** to the minutes - was adopted by acclamation.

**AD.2. Adoption of the Team's work regulations:**

Elżbieta Kois - Żurek - started today's meeting with a presentation of the draft regulations in connection with the Mayor of Krakow signing on June 7, 2019, order No. 1361/2019 regarding the establishment of the Interdisciplinary Team to Collaborate in the Implementation of the "Open Krakow" Program. The chairwoman presented the new wording of the regulations and drew attention to the new provisions obliging the Team Members to **verify the schedule of the Team meetings for 2019** with respect to the subjects of the meetings. The new formula of working teams makes it possible to take over certain subjects planned for the planar meetings for the implementation of working teams, therefore members of the Team proceeded to establish subjects for the

forthcoming meetings in September, October, November, December 2019. The new version is attached as **Appendix 3** to the minutes.

Then, the Chairwoman drew attention to the provisions of the regulations **on the necessity of publishing dates and places of meetings of working / task groups** on open.krakow.pl in the Interdisciplinary team tab, as well as the schedule of plenary meetings of the Team. The persons designated by the working group to notify the employee servicing the portal should send the set schedule for group meetings.

Another new provision in the regulations is the **obligation to notify absence at meetings** in order to record excuses. The form of reporting absences - by e-mail to the address poczta@um.krakow.pl. The entry in the regulations was introduced in order to ensure proper attendance at the meetings and fulfillment of the minimum attendance requirement, which is directly related to remaining a member of the team during the term of office. In the event of presence at a meeting, it is also important to take care of recording your presence on the list.

In order to provide information about the planned dates of meetings in 2019, the Chairwoman informed the Team members about the current publication of team documents on www.otwarty.krakow.pl in the interdisciplinary team tab (current meeting schedule, minutes, assembly order, report on the Team activities, etc.).
