NOTICE Submission of statements containing false data or suppression of data regarding own situation to the extent required by resolution No. XLVI / 568/08 of the City Council of Krakow of June 11, 2008 on the rules for the sale of residential premises owned by the Municipality of Krakow and defining the conditions for granting discounts and rates percentages (as
