## 12. Additional information for the client

a) Written bids are accepted by the Management Board of Municipal Buildings in Krakow during the period when the lists of residential premises for rent are displayed to the public, but no later than 3pm on the third working day preceding the auction day.

b) The bid security is payable by bank transfer or payment to the bank account indicated by the Management Board of Municipal Buildings in Krakow, no later, however, than by the third business day preceding the date of the procedure. The date on which the funds are credited to the account of the Management Board of Municipal Buildings in Krakow shall decide whether the deadline for the payment of the bid security is met. When making a payment to a bank account or transferring funds as a deposit, the Bidder should enter the date of the procedure, the address of the apartment for which the offer will be submitted, the index number in the list of premises for rent and the name and surname of the Bidder.

c) The documents listed in point 5 lit. b must be obtained no earlier than 3 months before the auction date
